

## COVID-19 GUIDELINES

1. AAWC, its club members, and all exhibitors will follow State and local guidelines. A waiver may be required of all participants, depending on the status of the disease this Fall
2. Participants and workers will not be required to wear facial coverings outdoors, but if any of our membership is uncomfortable with this, or has underlying health needs, please be respectful of one another. The club will not provide facial coverings.
3. We ask that you do your best to maintain some distance from people not in your household.
4. Roll Call will be done at a central location. We will ask the owners of females to wipe their dogs and show the inspection committee the tissue.
5. Wickets will be wiped down after each dog.
6. We will have hand sanitizer or wet wipes in various locations for use.
7. To maintain social distance for line judging, there will only be two judges on opposite sides of the line, and an electronic device setup on the line for recording every race. All participants will be able to view the electronic recording(s) upon request.
8. During conformation judging, keep 6' between participants, and the judge will be using hand sanitizer.
9. Please leave open the restroom door open when not in use, and the exhaust fan on at all times, for more air flow. Paper towels will be provided for drying hands. Please dispose of them in the appropriate receptacle.
10. DO NOT crowd the trial secretary table. We promise that everyone will have an opportunity to take a picture of the board and we will provide everyone with time to get their dogs ready. One at a time please.
11. Ribbons and Prizes will be provided at the end of the meet as usual – they may be laid out on a table for self-service, weather permitting.
12. If you are paying cash, PLEASE bring the exact amount – no change will be given.
13. Exhibitors who refuse to comply when reasonably asked to follow mask, sanitary or social distancing guidelines will be asked to leave the property.
